



A case study is a detailed study of a specific subject, such as a person, group, place, event, organization, or phenomenon. Case studies are commonly used in social, educational, clinical and business research. A case study research design usually involves qualitative methods, but quantitative methods are sometimes also used. Case studies are good for describing, comparing, evaluating and understanding different aspects of a research problem.

In a case study, nearly every aspect of the subject's life and history is analyzed to seek patterns and causes of behaviour. Case studies can be used in a variety of fields including psychology, medicine, education, anthropology, political science and social work. This method is one of the steps used in the clinical method of studying behaviour. This method is used for those who are suffering from physical or mental disorders. For this the case history has to be made of the earlier experiences of the individual which may be responsible for the present behaviour.

## PURPOSE OF CASE STUDY

A case study is a research approach that is used to generate an in-depth, multi-faceted understanding of a complex issue in its real-life context. It is an established research design that is used extensively in a wide variety of disciplines, particularly in the social sciences.

case studies generally have the following structure; it starts with a problem, then outlines the various different potential solutions available. This is, then, followed by proven cases when one of the solutions discussed is an individual solving the problem outlined. The main purpose of case studies, therefore, is to find a real-life application of a theoretical concept or solution. Most of the time, problems are or can be solved theoretically. The actual implementation of the solution however, can often be an unpredictable event. The world today is very volatile, and what is true today might not necessarily be true the next day. For any solution to be trusted, it is important to prove that it can be translated from the books or classroom to the field and that it can, then, work effectively when this happens.

## MERITS OF THE CASE STUDY

- To understand fully the behaviour pattern of the concerned unit.
- Helps to obtain a real and enlightened record of personal experiences.
- It facilitated the drawing of inferences and helps in maintaining the continuity of the research process.
- It enhances the experiences, analyzing ability, and skills of the researcher.
- It represents a real record of personal experiences which very often escape the attention of most of the skilled researchers using other techniques.
- The researcher can use different methods such as depth interviews, questionnaires, documents, study reports of individuals, and so on.
- It helps a lot to the researcher in the task of constructing the appropriate questionnaire.
- It helps in formulating relevant hypotheses along with the data which may be helpful in testing them.

## DEMERITS OF THE CASE STUDY

- The case study method can be used only in a limited sphere, it is not possible to use it in the case of a big society. Sampling is also not possible under a case study method.
- It consumes more time and requires a lot of expenditure. More time is needed under the case study method since one studies the natural history cycles of social units and that too minutely.
- The case study method is based on several assumptions which may not be very realistic at times, and as such, the use of case data is always subject to doubt.
- The danger of false generalization is always there in view of the fact that no set rules are followed in the collection of the information and only a few units are studied.
- The case data are often vitiated because the subject, according to reading brain, may write what he thinks the investigator wants, and the greater the rapport, the more subjective the whole process is.
